This cause, having come before this Court on a prove-up of damages following the default of Defendant Wprost, Agencja Wydawniczo-Reklamowa "Wprost" S.P. Z.O.O., Marek Krol and Maciej Rybicki, this Court, having conducted a jury trial on the issue of damages and the jury having rendered a verdict on damages and this Court entering judgment on that verdict, with one change as set forth below:

IT IS HEREBY ORDERED

- 1) Judgment is hereby entered in favor of plaintiffs and against defendant 9101
- 2) Actual damages in the amount of \$ 250,000 are awarded to plaintiff Russell J. Harlan jointly against all defendant
- 3) Actual damages in the amount of \$ 750,000 are awarded to plaintiff Malgorzata-Natasza Cimoszewicz aka Natasza Harlan jointly against all defendant 9101

3) Punitive Damages in the amount of \$4,000,000 is ~~entirely~~ awarded to both plaintiffs collectively ~~jointly~~ against Defendant Wprost, Agencja Wydawnicza - Reklamowa "Wprost" S.P. Z.O.O., and Marek Krol jointly.

4) Punitive damages were also awarded by the jury against Defendant Maciej Rybinski, but this Court, having found that the evidence presented at trial does not warrant the award of punitive damages against Defendant Maciej Rybinski, does not enter judgment on the punitive damage award against Maciej Rybinski.

5) This judgment is reduced as to each plaintiff in the amount of \$4500 apiece based upon the \$4500 settlement that each plaintiff received from Lowell International Company. This reduction will be made from the actual damages awarded to each plaintiff, leaving a final award of actual damages in favor of Russell J. Harlan of \$245,500, and in favor of Malgorzata-Natasza Cimoszewicz in the amount of \$745,500.
